* **Blessed in the city and the field... fruit of your body... fruit of your ground (v.3-4):** America became the "breadbasket of the world" with immense agricultural abundance. Its population grew explosively through high birth rates and selective immigration from other Israelite nations.

His life, death, and resurrection opened the way to salvation for all humanity, Jew and Gentile alike, who would come to God through faith in Him.

****The Continuing Barrier and the Paganized Church****

The primary barrier to unity and understanding today is exactly as you state:
